EVA TANSKY BLUM EXECUTIVE VICE PRESIDENT PNC BANK

Eva Tansky Blum is executive vice president and director of Community Affairs for PNC Bank. Blum also serves as chairwoman and president of The PNC Foundation.

In this role, Blum works with PNC's businesses and regional presidents in establishing the strategy to position PNC as a leader in the community. She directs the company's philanthropic programs, including PNC Grow Up Great, a \$350 million, multi-year, bilingual initiative that began in 2004 to support quality early childhood education.

Blum joined PNC's Legal division in 1977. She became vice president in 1986 and was elected senior vice president and chief compliance counsel in 1990. She served as senior vice president and deputy general counsel/director of Regulatory Affairs for PNC, and recently served as senior vice president and director, Comprehensive Risk Management and Compliance. She was named to her current position in July 2002. She was promoted to executive vice president in February 2013.

Blum is a member of both the Pennsylvania and Allegheny County bar associations. She also holds several roles with her alma mater, the University of Pittsburgh. She serves on the school's board of trustees; Co-Chair's Pitt's \$2 billion capital campaign; is the head of the Graduate School of Public Health's (GSPH) board of visitors; and is past president of the University of Pittsburgh Alumni Association. Blum is also a member of the honor board of WQED Multimedia; serves on the advisory board of the Carnegie Science Center and is a board trustee for the Jewish Healthcare Foundation.

In 2001, Blum was honored as a Carlow College Women of Spirit®; in 1999, she was honored as one of Pennsylvania's Best 50 Women in Business; in 1998, she received the YWCA's Tribute to Women award; in 2007 was named the University of Pittsburgh's Distinguished Alumnae of the Year; in 2009 was named a Distinguished Daughter of Pennsylvania; in 2011, she received the YWCA Allerton Award; in 2012, received the Mt. Ararat Community Activity Center Recognition Award; and in 2013, received the Andrew W. Mathieson Award for FAME.

Blum received a Bachelor of Arts degree in 1970 from the University of Pittsburgh and graduated from that University's School of Law in 1973.
